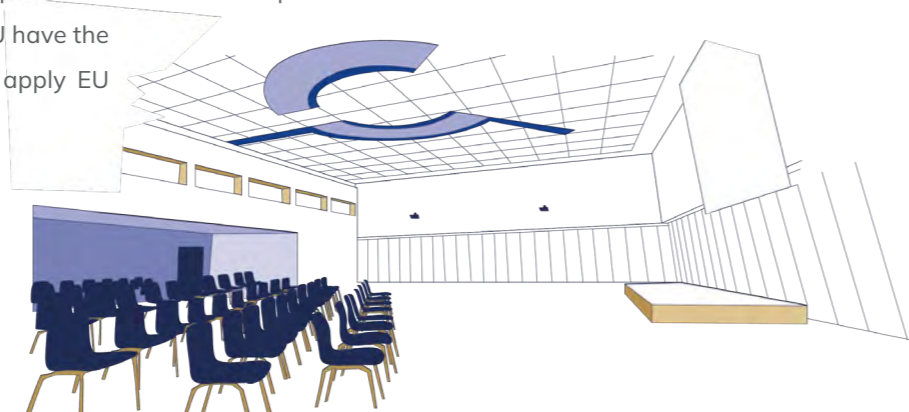


We are a centre of expert knowledge and debate on European law providing you with the opportunity to learn, discuss and network with top speakers about the ever-changing legal framework.

Methodology

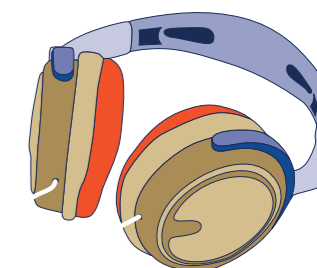
Our Open Event Programme includes:

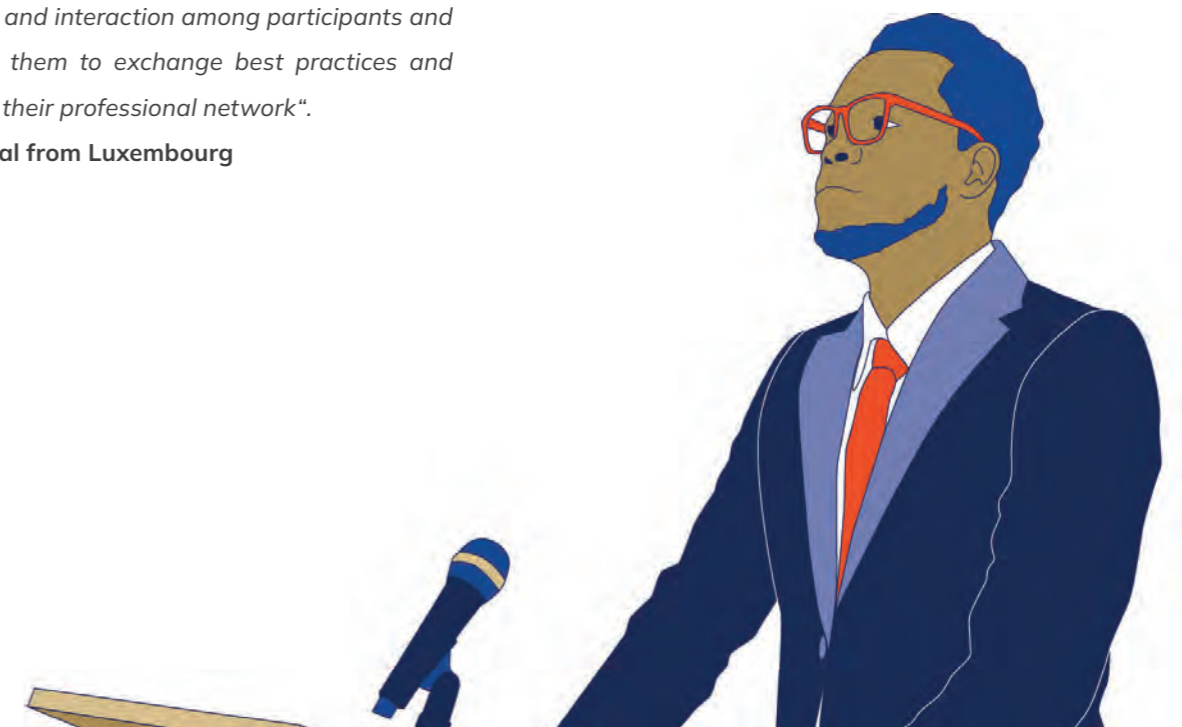

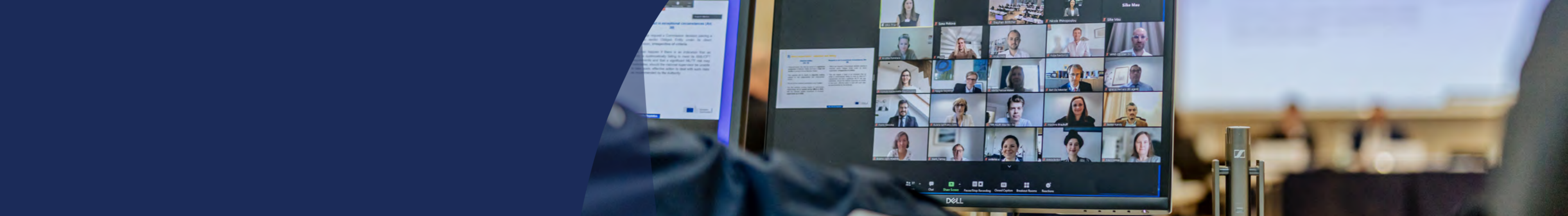
